## The Lincolnshire Landscape

- Rural county of 6,959 km<sup>2</sup>
- Widely dispersed population of circa 760,000.
- Limited public transport, no motorways and few dual carriage-ways.
- Very high level of dispensing GP practices (85, of which 24 are 50% or higher dispensing)
- Largest number of care homes in county in the UK (293\*).

Understanding this landscape is key when working within the ICS.

#### Considerations

The current restructures across the pharmacy representative landscape require Community Pharmacy Lincolnshire to consider the following 4 elements:

- NHS Boundaries: Matches NHS boundaries (Integrated Care Board (ICB)), having a representation and governance structure (LPC members) at a system level
- 2. System and place-based working: Able to invest executive resource to undertake system and place-based work.
- 3. Finance and Justification: Able to meet increased contributions to PSNC, without having to increase contractor levies
- 4. LPC Size: 200 contractors or above

## Constitution & Elections Delay

- Propose to adopt the new model constitution
- Although we are not proposing significant changes in Lincolnshire, important to align ourselves with the national model as much as possible, therefore propose a delay in elections for the next four-year term from 2023/24, meaning new committee formed from July 2023 rather than April 2023
- The new constitution will restrict committee members to a maximum of three, four-year terms as from the proposed formation of the next committee in July 2023.
- CPL already employs the other governance elements within this new constitution, for example those around finance and conflicts of interest, and will continue to do this moving forward.
